Abstract The Columbianum was a Philadelphia association comprised of

thirty professional and amateur artists established in 1794 and ceased operations soon after in 1795. This collection consists of the original manuscript copy of the association's by-laws, constitution, a

photocopy of its 1795 exhibition catalogue, an association agreement, and an undated history of the organization.

Historical note

The short-lived Columbianum, an association of thirty professional and amateur artists, factious from the outset, sponsored a single exhibition, which was held in Independence Hall, and hastily planned an academy for art instruction. Much to the disappointment of Charles Willson Peale and other artists, the Columbianum ceased to function in 1795. Rembrandt Peale recorded in his 1855 *Reminiscences*, published in *The Crayon*, that it "died a natural death, by schisms."

Scope and Contents note

This collection consists of the original manuscript copy of the society's by-laws, constitution, a photocopy of its 1795 exhibition catalogue, an association agreement, and an undated history of the organization.

Most of this collection has been microfilmed by the Archives of American Art. See the reel numbers listed below.

Apparently, in 1821 Rubens Peale used the later pages of this volume as a letterbook. The two parts have been separated and bound as two items. See the papers of Peale's Museum below for more information. The manuscript of the constitution is filmed on reel P45:405-19. The 1795 printed version of the constitution is filmed on reel P52:586-95.
