

Historical note

The position of president was created in the administrative reorganization of 1983. The position is similar to the chief executive officer of a corporation, with department heads for the museum, school, development, and finance reporting to the president. It should be noted that the chairman of the board of directors was referred to as the President of the Academy until 1974.

Gresham Riley, PhD, graduated Baylor University with a B.A. in Philosophy. He received his M.A. and PhD in Philosophy from Yale University. He was awarded a Fulbright Scholarship, a Woodrow Wilson Fellowship, and a Danforth Fellowship. In 1968-1969, Dr. Riley served as a research fellow at the Center for Advanced Study in the Behavioral Sciences at Stanford University. He was a Professor of Philosophy at Colorado College, the University of Richmond, and New College.

He was selected to be PAFA's president in 1994, a position he served until his resignation in 1997. Riley maintains that he had finished the work he came to PAFA to complete, such as solidifying finances and increasing enrollment. He and the board agreed that "it is time for new leadership to carry out the [seven-year] strategic plan which I and my staff have been developing."

An interim CEO will be named forthwith, but Riley remained in the position of president until the end of the fiscal year on July 31, 1998.
