THE ANNUAL REPORT TO THE STOCKHOLDERS

The President and Directors of the Pennsylvania Academy of the Fine Arts have the honor to present their 126th Annual Report.

Stockholders' tickets for the calëndar year 1932 were mailed to you on December 31st, 1931. These tickets will admit the stockholder to all lectures and entertainments given by the Academy or under the auspices of the Academy whether an admission be charged to the public or not. The President and Directors will be most gratified by the frequest use of these tickets.

EXHIBITIONS

The 127th Annual Exhibition in Oil and Sculpture opened to the public on January 24th, 1932, preceded by a Private View on Saturday evening, January 23rd, and continues through Sunday, March 13th, 1932. The motive dominating the gathering together of this Exhibition has been strictly educational. To obtain this result, the Management of the Academy selected a chairman and a Jury who were known to be sufficiently broad-minded to appreciate the excellence and sincerity of the work presented for their judgment, regardless of the type under which the work might be classified. The result is that this Exhibition gives an unusually comprehensive idea of work being done at this time by our American artists. The art critics have so favorably written up this Exhibition that the attendance. so far, has been decidedly increased over that of recent years. The Exhibition was in the hands of a Jury of Selection consisting of eleven painters and three sculptors, who judged all of the work submitted. The Hanging Committee consisted of the Chairman and two other jurors together with the President, ex-officio, who arranged the hanging of the exhibits.

The canvases were selected by the Painters' Jury of Selection, consisting of -

Most of the paintings in the Exhibition are for sale and there are many that are suitable for hanging in private houses or apartments. The Sculpture Exhibition contains much that can be used for the decorating of interiors as well as placing in the open.

The 126th Annual Exhibition opened according to schedule on January 25th, 1931. The awards of medals in this Exhibition were made by the 1931 Jury of Selection, and were as follows:

Temple Medal awarded to Alexander Brook for the best painting irrespective of subject, for his canvas entitled "The Intruder".

Jennie Sesnan Gold Medal for the best landscape awarded to John Folinsbee for his canvas entitled "Canal and River".

Carol H. Beck Gold Medal for the best portrait in the Exhibition awarded to John Sloan for his canvas entitled "The Sculptor Vagis".

The Sculptors' Jury of Selection awarded the George D.Widener Medal to Gladys Edgerly Bates for her exhibit entitled "Eve".

The James E. McClees Prize was awarded to Edward McCartan for his exhibit entitled "Dionysius".

The following prizes were awarded by the Committee on Exhibition consisting of members of the Board of Directors:

> Walter Lippincott Prize awarded to Sydney E.Dickinson for his canvas entitled "Mary" (best figure piece)

The Mary Smith Prize for the best work by a Philadelphia woman awarded to Mildred B. Miller for her canvas entitled "Yuanshi Kuo".

The Exhibition consisted of 361 paintings and 148 exhibits of sculpture. 386 artists were represented. The total attendance at this Exhibition was 20,671. Immediately after the close of the 126th Annual Exhibition, the permanent collection was put in place in the galleries with the exception of Gallery "H" which was hung with a collection of fifteen Silver Points by Ercole Cartotto, together with a selected group of Water Colors selected from the Academy's Permanent Collection. This combined Exhibition was open to the public during the entire month of April.

On May 16th, Galleries F, G, H, the North Transept, the East and West Central Galleries and the Rotunda were occupied by an Exhibition of work by our students in competition for the William Emlen Cresson Memorial Travelling Scholarships and minor school prizes. This Exhibition opened to the public on May 28th, when the students and their friends were addressed by Mr. Walker Hancock. Mr. John Frederick Lewis, the President of the Academy announced the awards. Twenty-nine groups of work recommended by the Faculty and ratified by the Board of Directors were awarded Travelling Scholarships. The Exhibition was open to the public for two weeks, after which the galleries were hung with the permanent collection for the Summer months. During the period that the School Exhibition was on in the galleries, an Exhibition was held in the Print Room, of the first and second prize freehand drawings sent in from various high schools and private schools in Philadelphia and vicinity. These prizes were awarded by the Academy to the work as nominated by the art instructor in each school represented. These drawings after being put on exhibition were awarded first, second and third prizes by the Academy's Faculty, as follows: -

Cash Rinks water Million

On October 13th, all of the galleries excepting B, the South Transept, C and D, were dismantled for the 29th Annual Water Color Exhibition, the 30th Miniature Exhibition and the 15th Exhibition of work done at the Academy's School at Chester Springs. These Exhibitions were open to the public from November 1st to December 6th, 1931. The Jury of Selection for the Water Color Exhibition consisted of -

On November 18th, an Exhibition was open in the Print Room on the first floor of the Academy showing 213 drawings representing 21 art schools in competition for the Charles M. Lea Prizes. The prizes were awarded as follows: lst - Victor H. Carlsen of the School of the Pennsylvania Academy of the Fine Arts

2nd - Paul C. Burns of the Pennsylvania Museum's School of Industrial Art

3rd - Elliot Howard of the Portland School of Fine Arts, Portland, Maine.

These awards were made by the Jury of Selection for the 29th Annual Water Color Exhibition.

The Total number of visitors to the Galleries for the year 1931 was 59,105.

SCHOOLS

The Schools of the Academy had a successful year with a total registration of 269 students. Instruction in the school is given by a faculty of recognized artists in the Art World consisting of -

The school is under the management of the Committee on Instruction which consists of members of the Board of Directors. The Chairman of the Committee is Arthur H. Lea who is also Chairman, ex-officio, of the Faculty. The School is under the direct management of the Curator, Eleanor A. Fraser. School enrollment for the Season 1931-32 is now going on. Our students are bringing great credit to their instructors and indirectly to the Academy through their work being accepted by Juries judging work submitted for the most important general exhibitions of the country. In our current 127th Annual Exhibition, one of our students was awarded the Mary Smith Prize and a former student was awarded the Albert C. Lehman Prize and the First Prize in the Carnegie Exhibition at Pittsburgh.

Our country school at Chester Springs has had a successful year. It has proved sufficiently well attended to warrant its continuance as an all year round school. It is under the direct Management of D. Roy Miller as Resident Manager. Instruction is given by a regular faculty consisting of -

As a means of special stimulus, outstanding artists from elsewhere have been invited to give a limited number of criticisms. At this date there is a total of 55 students enrolled. The total enrollment for the calendar year 1931 was 242. During the year necessary carpentry work, repairs, etc. were attended to FREE CONCERTS

On April 12th and April 19th, 1931, two free Sunday concerts were given in the galleries of the Academy, under the auspices of Clara Barnes Abbott, Chief of the Bureau of Music, City Hall, but later, owing to the financial situation of the City, the Bureau of Music has been discontinued and consequently the usual free Sunday concerts in the galleries of the Academy have not been given.

At present one of the members of the Board of Directors is arranging with a private committee in an endeavor to hold free Sunday afternoon concerts for a short Season after the close of the 127th Annual Exhibition.

The usual City appropriation of \$20,000 was reduced to \$15,000. for the year 1931 and for 1932 was discontinued by the City Council.

BUILDING

No repairs were necessary on the roof. The Walls of Gallery F were dismantled of their covering and the wooden backing.to a heighth of seven feet, was renewed. The walls were then covered with vassar cloth in conformity of a number of the other galleries. The coves, columns and wainscoting were given several coats of paint as well as the muttons of the skylights. Repairs in the concrete floor of the West Central Gallery were made. On the Street floor, glass in the Rear Life Painting Class room was replaced with lensrib glass which throws into the classroom about 30% additional light. All of the lockers in the school were painted. The floors in the Painting Class were painted and in the Sculpture Class, the floors were oiled. The walls

and ceilings were all given a coat of fresh calcimine and woodwork given a fresh coat of paint where necessary. The walls of the stairway lobby, the entrance lobby, the Print Room, the large front office and the Secretary's office were washed down and the woodwork of the last named office was given a coat of paint and the floors of both offices were painted. In the basement, all the fire doors were painted and all the walls whitewashed. A new return steam line was put through the center corridor and the heating plant thoroughly overhauled and put in order for the Winter. All fire extinguishers in the building were emptied and refilled. At the annex at 1834 Arch Street, the exterior rear of the building was painted including the woodwork and the fire-escape. New window sash were placed in the front basement with reframing. The floors throughout the building were repaired and repainted. All of the work of repairing, etc. both at the Academy and at the Annex, with the exception of the re-covering of Gallery F wall, was done by our own employees.

The recent break in the high pressure water main on Broad Street seems to have caused no damage to the Academy building or its contents.

The Treasurer's report in detail is submitted. The thanks of the Management of the Academy is extended to the Honorable The Mayor of Philadelphia, the Mayor's Cabinet and Council for their support in the past, to the President and members of the Board of Education in sending to our Schools students who wish to study art. We also acknowledge our debt,

to the Press of Philadelphia which has given to the Academy and to the cause of Art, intelligent criticisms of all the Exhibitions we have had. We also make grateful acknowledgment to the employees of the Academy for their faithful performance of their duties.
