# TO THE STOCKHOLDERS:

The President and Directors of the Pennsylvania
Academy of the Fine Arts have the honor to present
their 115th Annual Report.

Your Stockholder's Tickets for the calendar year of 1921 were mailed to you on December 31st, 1920. These tickets will admit the Stockholder to all lectures and entertainments given by the Academy or under its auspicies whether admission be charged to the public or not. The President and Directors would be most gratified by the frequent use of these tickets.

## EXHIBITIONS

The 116th Annual Exhibition of work in Oil and Sculpture opened to the public on Sunday, February 6th and continues through Sunday, March 27th. This Exhibition is of unusual importance, since there is a wider representation of current American art than in recent years, and every part of the Country is represented as well as the colony of artists working in Europe.

The Exhibition is in the hands of a Jury of Selection consisting of eleven painters and three sculptors who judged all work submitted. The Hanging Committee which is composed of a Chairman of the Jury and three other Jurors together with the President, Ex-Officio, arranged the Galleries for the Exhibition. The canvases and the pieces of sculpture which have been selected by the Painter's Jury consisted of;

The awards for the 115th Annual Exhibition made by the Jury of Selection were as follows:

The Temple Gold Medal - for the best painting irrespective of the subject - to Ernest Lawson for his canvas entitled "Ice Bound Falls".

The Jennie Sesnan Gold Medal - to Hugh H. Breckenridge for his canvas entitled "The Edge of the Woods".

The Carol H. Beck Gold Medal - for the best portrait to Eugene Speicher for his canvas entitled "Portrait of a Russian Woman".

The Sculptor's Jury of Selection awarded to Malvina Hoffman the George D. Widener Memorial Gold Medal for her work entitled "The Offering"

The Board of Directors of the Academy awarded the Academy Gold Medal of Honor to Childe Hassam in recognition of his high achievement in his profession.

The Following awards were made by the Committee on Exhibition consisting of members of the Board of Directors:

The Walter Lippincott prize to Joseph DeCamp for his canvas entitled "The Red Kimono".

The Mary Smith Prize for the best canvas by a Philadelphia

woman artist to Mildred B. Miller for her canvas entitled "In the Window".

The Edward T. Stotesbury Prize for the painting which is the most important contribution to the success of the Exhibition - to Edward W. Redfield for a group of three paintings.

The Philadelphia Prize awarded by popular vote during a designated week in March to Alfred R. Mitchell for his canvas entitled "Over the Valley: San Diego".

The Exhibition consisted of 360 paintings and 158 exhibits of sculpture. 333 artists were represented. The total attendance for the 115th Annual Exhibition was 45,505.

Immediately after the 115th Annual Exhibition closed, the Galleries were prepared for the loan Exhibition of work in oil, water color. black and white and sculpture by modern masters. Exhibition was on the walls of the North Galleries from April 15th until May 15th. This was considered by artists, collectors and other connoissuers to be the most important Exhibition of the kind ever held in the Country. The influences from the time of Gustav Courbet leading to the ultra modernist of the present were shown with a remarkable sequence of some of the finest examples of all of the important artists who contributed to the Two hundred and twenty (220) pieces were shown. Exhibition was collected by Mr. Arthur B. Carles, a member of the Faculty of the Academy, and Mr. Carroll S. Tyson, Jr., of Philadelphia to whom the thanks of the Academy are due as also to the generous cooperation of the owners of the pictures in the group.

Immediately after the close of this Exhibition, the Annual Exhibition of work of the students was hung in groups in the Galleries in competition for the William Emlen Cresson Memorial

Traveling Scholarship and the minor school prizes, until June 5th when the entire Galleries were than hung with the Academy's permanent collection. Ten groups were recommended by the Faculty for Cresson awards ratified by the Board of Directors and announcement in the Galleries to the students was made on May 26th. From December 12th until Jahuary of the present year. the entire Galleries were occupied by the permanent collection.

#### SCHOOLS

The Schools of the Academy have had a very successful Y year. Since traveling conditions in Europe have sufficiently imprev-

ed to permit of students going abroad, the Cresson Traveling Scholarships awarded since the begining of the World War have become available for enjoyment by the recipients. During the year fortyfive (45) students went abroad. sixteen (16) have returned. The keenness of their enjoyment of their Scholarships has caused most of them to return to the Schools for further study, and indirectly has greatly increased the enthusiasm for work among the students in competition for the Cresson Traveling Scholarships.

The work of the Schools is of an unusually high quality due to the excellence of the Faculty which consists of the following artists:

The School is under the Management of the Committee on Instruction which consists of members of the Board of Directors of which Committee the Hon. The number of enrolled students for the present season is 245. The enrollment is now going on for the second term of the school year.

A group of admirers of the work of the late Emily Bishop as well as intimate friends, have placed on the walls of the Lobby of the Academy at the entrance to the Schools, four low reliefs, a Portrait bust by Miss Bishop, and a portrait bust of Miss Bishop by Charles Grafly as a memorial to Miss Bishop.

Miss Bishop was one of the Schools' most promising students.

The Academy's Summer School at Chester Springs, Chester County, Penna., has enjoyed the most successful season of the four years which it has been opened to students.

Instruction was given from April 1st until October 1st, and included criticisms for various periods by the following artists:

The total number of students enrolled during the season was 183. There is a marked tendency for students to increase their period of study at the School.

The attendance is almost exclusively obtained through the students recommending the advantages of the Chester Springs School their friends which seems to indicate an assured future for this Summer School.

The 4th Annual Exhibition of work done at the School was shown in Galleries G and South Corridor of the Pennsylvania Academy of the Fine Arts from November 6th until December 12th, 1920. This Exhibition was of such excellence that it received the highest praise from art critics.

### FREE CONCERTS

In the Management of a Special Committee of which Mrs. Herbert L. Clark was chairman, a series of Free Sunday Concerts were given in the Academy during April and May, and Novemebr and December of 1920. These Concerts continued to meet with popular appreciation and the music was of the very highest type and in keeping with the dignity of the Academy. The total attendance for the year - 165,099.

The Herbert Marshall Howe Memorial. On October 1st, 1920 Mrs. Herbert M. Howe presented to the Academy \$10,000.00 as a memorial to her late husband, Herbert Marshall Howe, who for many years was a Director of the Academy of the Fine Arts and was Chairman of the Committee on Instruction. The income from this memorial is to be used for the support of the Schools of the Academy.

# BUILDINGS

No new construction work has been done during the year but necessary repairs have been made to the roof. The East and West Central Galleries have been recovered with burlap. The wainscoting has been repainted. The schools walls have been cleaned and recalcimined and windows and floors painted. On the main floor the experiment of prism glass in the portrait room of the schools has proven successful and seems to eliminate all objections to the reflections from the high buildings on the opposite side of Cherry Street. In the basement the walls have

been whitewashed and the steamheating plant put in good order for the Winter season.

On the exterior of the building, the sidewalks on both Broad Street and Cherry Street have been put in good condition, and in accordance with the Fire Department regulations the fire extinguishers were refilled with fresh chemicals.

The Treasurer's report in detail was submitted.

The thanks of the Management of the Academy is extended to the Honorable the Mayor of Philadelphia, to the Mayor's Cabinet and to the Council for their continued sympathy and their support and to the President and Members of the Board of Education in sending to our Schools students desiring to study art.

We also acknowledge our debt to the Press of Philadelphia which has given to the Academy and to the cause of art intelligent criticisms of all of the Exhibitions which we have held.

We also make grateful acknowledgement to the employees of the Academy for their faithful performance of their duty.
