Subject: Change Order No. 1-62

We hereby accept your proposal dated February 26, 1970 subject to your signing our standard form of subcontract and conditions outlined in the Department of Public Works letter dated March 10, 1970, a copy of which is attached and made a part hereof. Please note this letter does not stipulate a contract price although your letter does. Acknowledgment and substantiation of contract price by the Department of Public Works is required.

Furthermore, forthcoming payments are predicated upon the Department of Public Works issuance of payments to the General Contractor, against the above Change Order; receipt of said payments by us will cause us to release payments to you.

All related work is to be done in strict accordance with plans prepared by the Architects, Viola, Bernhard & Phillips dated January 25, 1966, Specifications for Project HD-60, Information for Bidders, Agreement, Contract Documents and Addenda #1 and #2 to Contract Documents, General Conditions and Addenda #1, 2 & 3 to General Conditions, General Construction and Addenda 1,2,3,4,5 and 6 to General Construction.

Kindly furnish us with the required insurance certificates, in triplicate, as follows: Workmens Compensation and Public Liability with minimum limits of 200,000/500,000 for Bodily Injury and 25,000/50,000 for Property Damage.

It is specifically understood and agreed that you will diligently prosecute the work contained herein in accordance with instructions, and under the direction of Mr. John Rhoden, Sculptor.

Should you fail to sign and return to us the original hereof within 10 days of the date hereof, we reserve the absolute option to notify you at any time after the expiration of said 10 days that all negotiations looking toward an agreement have been terminated and that neither of us has any liability to the other whatsoever arising out of or in connection with the above project.
